WHAT IS THE LOCAL PRESCHOOL TASK FORCE?

If you are involved with your Committee on Preschool Special Education, a provider of service for preschool students with disabilities, an approved preschool special education provider, a child care or Head Start provider, County representative or other interested party, the Preschool Taskforce is the committee to attend. ECDC is currently the chair of both the Erie Preschool Taskforce and the Niagara-Orleans Preschool Taskforce.

In attendance, along with your colleagues, are representatives from the county, Special Education Quality Assurance (SEQA), Regional Special Education Training and Resource Center (SETRC) and the Early Childhood Direction Center.

The taskforce is an opportunity where all professionals who are involved in providing services to preschool children with disabilities gather to discuss common concerns, formulate decisions, and learn about New York State special education updates.

A typical agenda includes: updates from representatives of VESID, field memos, information on SPPs, IEP Direct or Clear Track, collaboration strategies, workgroups that are developed around a common regional concern, discussions about elimination of duplicative forms and procedures and most importantly brainstorming. The task force is a unique opportunity where you can get questions answered and facilitate discussion with your fellow providers of services. We only meet four times per year and it is worth the effort.
