
Good afternoon,

Legionella and Pneumonia (Update)

- High summertime Lake Erie water temperature fosters the growth of Legionella in our water supply system
- There is an annual rise in cases from June through September, and this year is following past trends

- While our focus has been on COVID-19 as a cause of pneumonia, we must remember that other pathogens, including *Legionella*, are still important causes of lung infection
- Please remember to order a *Legionella* urinary antigen and a *Legionella* sputum culture whenever possible for patients admitted with pneumonia

Geographic and Genomic Distribution of SARS-CoV-2 Mutations

- A recent article in the journal Frontiers in Microbiology discusses the mutation of the coronavirus
- At present, there are at least six known strains, but the authors suggest that despite these
 mutations, the virus shows little variability, and they believe that this will make it a more viable
 vaccine candidate

Risk of COVID-19 among Front-line Health-care Workers and the General Community: A Prospective Cohort Study

- In the UK and the USA, risk of reporting a positive test for COVID-19 was increased among frontline healthcare workers. Healthcare systems should ensure adequate availability of PPE and develop additional strategies to protect healthcare workers from COVID-19, particularly those from Black, Asian, and minority ethnic backgrounds. Additional follow-up of these observational findings is needed

Neurological and neuropsychiatric complications of COVID-19 in 153 patients: A UK-wide surveillance study

- A recent article in Lancet addressed the neurologic implication of COVID-19
- The authors report that "to our knowledge, this is the first nationwide, cross-specialty surveillance study of acute neurological and psychiatric complications of COVID-19. Altered mental status was the second most common presentation, comprising encephalopathy or encephalitis and primary psychiatric diagnoses, often occurring in younger patients."

Clinical Course and Molecular Viral Shedding Among Asymptomatic and Symptomatic Patients with SARS-CoV-2 Infection in a Community Treatment Center in the Republic of Korea

- An article was published last week in JAMA Internal Medicine addressing the question of whether there are viral load differences between symptomatic and asymptomatic patients with severe coronavirus infection
- The authors found that there is not a difference and suggest that tracking/isolation of asymptomatic patients may be necessary to control the spread of the virus

Prevalence of SARS-CoV-2 Antibodies in Health Care Personnel in the New York City Area

- A research letter was published in JAMA which sought to investigate the prevalence of antibodies against the coronavirus among healthcare workers in the New York City area
- The authors found an incidence of 13.7% which was similar to the benchmark rate across New York State 14%

Today's theme is about remembering that the journey is our destination. Today, many of us will mark the 91st anniversary of Babe Ruth hitting his 500th home run. For baseball fans, it is a significant milestone, but that home run is only relevant in the context of a longer career. It would never have arrived if Ruth had not spent the prior 15 years mastering the art of baseball and hitting the first 499 home runs. As soon as he hit that ball, the goal simply became another marker in his record book. Too often in life, we are tempted to believe that there are certain objectives which – once achieved – will

ensure that we have on-going happiness. For many of us, it may have been getting into and then subsequently graduating from a given training program, getting a particular job, or working on a particular project. What we inevitably find is that the endpoint soon becomes a simple milestone on a longer journey as we refocus and move ahead. Today, as a nation, we are met with this very challenge. Too frequently, we hear conversations about getting beyond COVID-19 and getting back to the way things once were. Crowded beaches in Florida and a quarter of a million Harley Davidson owners in Sturgis, South Dakota bear witness to the fact that many of our neighbors feel that they have gone as far as they want in dealing with COVID-19. They have crossed their personal thresholds and want to return to the familiar. As healthcare workers, we do not have this luxury. We have an obligation to our patients and our community to understand that life is not always so simple, and victory is not always so clear. It is likely that we will never have satisfaction of declaring victory over this virus. In time, the challenges of the coronavirus will likely fade into the past, but this will not come with a moment to pause or relax. Experience has shown that COVID-19 will most assuredly be replaced by a novel challenge or perhaps the reemergence of an old one. Instead of worrying about our destination, we must keep our eyes focused on our journey. This journey - the practice of medicine - will not end with the passing of this virus. Our patients will have new challenges, and we must be ready to care for them. We will do this by practicing medicine as we were taught with a focus on the patient and a belief in the power of science. As a healthcare community, we will never arrive at a final destination, but we can take pride in knowing that our neighbors will be better off because of the journey we are on.
