HEALTHY FACT: WESTERN NEW YORK POISON CENTER



It's back to school time and when parents are busy children can get into things that they shouldn't. Young children are at the greatest risk for poisoning because they mimic the behavior of adults. The Western New York Poison Center has compiled a list of the top five substances involved in poisoning in children under the age of six.

1. Cosmetics and personal care products
2. Cleaning Substances
3. Analgesics:
acetaminophen, aspirin, ibuprofen
4. Plants
5. Foreign bodies (toys, batteries, coins)

It is important to pay attention to the supervision of children. If a child does ingest something from the above list or anything else you have a question about, you can call the poison center for instructions at 1-800-222-1222

Dear ECDC,

My daughter's child care teacher is getting frustrated and writes me notes or tells me almost everyday about the inappropriate behavior that she displays. Her teacher says that my child has challenging behaviors and shows signs of having developmental delays. A friend has told me that you can offer parent support as well as free consulting and technical assistant for the child care teacher. What free support and services do you provide?

Diane Salverson replies:

ECDC's primary purpose is to provide training and technical assistance to parents and professionals working with children, less than 5 years of age, with suspected or diagnosed delays or disabilities. ECDC's Inclusion Specialist can, with the child care director's approval, provide free and confidential individualized sessions and technical assistance for child care professionals. This assistance can help identify children who have special needs and offer strategies to include them in typical child care settings as well as provide strategies for behavior management.

Our emphasis is on improving the options and opportunities for children with disabilities to be served in typical early childhood settings. Other ways that we accomplish this is through increasing family involvement, parent education, staff development and training, environmental modifications, professional workshops, information and referral for families such as Early Intervention (EI) birth to 3 years old, Committee on Preschool Special Education (CPSE) 3-5 years old and Committee on Special Education (CSE) 5 yrs old and up.
